#### **APPROVAL OF MINUTES:**

Christian updated the board regarding the marketing group. They have a long list of marketing items that can be done to be proactive. Fuse is ready when we are ready to move forward.

Colburn updated the board regarding the dams and Brownfield activity regarding the property at 141 West Front.

Klein recently met with United Airlines who is pleased with the market. Denver flight will be coming back along with some other weekend flights added.

#### RURAL BROADBAND OPPORTUNITY

The US Dept of Agriculture is seeking applications for \$600 million in financial assistance (grants and loans) to build out local broadband infrastructure in rural areas. Focus is on communities with fewer than 20,000 residents with no broadband today or with less than 10 mbps download, 1 mbps upload; and agriculture, health, education and e-commerce facilities. Deadlines to apply start in April 2019.

It is worth discussing whether Grand Traverse Economic Development Corporation might spark regional dialogue/ collaboration among potentially interested private and public parties, to pursue these funds. This might include the Chamber, TC L&P, townships, counties adjacent to Grand Traverse, ISPs and the GT Band of Ottawa and Chippewa Indians. The Leelaneau Economic Foundation expressed interest.

Traverse City resident, and former State Senator, Jason Allen is Director of the US Dept of Agriculture-Rural Development for the State of Michigan.

#### DRAFT- PROPOSED 20 FATHOMS & GTEDC AGREEMENT

Dear [ ],

This letter serves as 20Fathoms' agreement with the Grand Traverse County Economic Development Corporation ("GTEDC"), whereby 20Fathoms' has agreed to assist GTEDC in its mission to strengthen and revitalize economic development in Grand Traverse County and associated region, ("Grand Traverse") by providing the following services:

- 1. In order to assist GTEDC in carrying out its mission of improving economic development in Grand Traverse, GTEDC, its Board members and designees, shall have access to the 20Fathoms Technology Hub & Business Incubator, which shall include access to relevant events and schedulable conferences rooms within 20Fathoms, when relevant, and shall include all of the rights and privileges that accompany Contributor level access, as provided in the attached Exhibits which are incorporated herein by reference.
- 2. Representatives of GTEDC and of 20Fathoms shall develop, within 60 days of the date of execution of this Agreement, an engagement plan providing for specific use of the services described in above paragraph 1 of this Agreement. This engagement plan shall include, but not be limited to the following:
  - 1. ways and means for employees and representatives of the public sector entities that participate as members of GTEDC to improve their skills in innovation and leadership by participating in 20Fathoms

sponsored activities;

- 2. joint marketing, including logo placement on, and linking their, respective websites;
- 3. Periodic Reports (no less frequent than quarterly) by 20Fathoms on its progress to improve economic development in Grand Traverse, and implementation of the aforementioned engagement plan.
- 3. In return for the aforementioned services, GTEDC shall pay 20Fathoms \$3,000 per year, beginning [ ], 2019. 20Fathoms shall invoice GTEDC on a quarterly basis in 25 percent incremental amounts.
- 4. The initial term of this agreement shall be 12 months, and this agreement will be renewed for subsequent 12- month periods unless either party shall serve 60 days written notice to terminate the agreement.

We look forward to partnering with GTEDC to accelerate economic development in the Grand Traverse region.
