

Resolution 179-81
Ordinance No. 8

GRAND TRAVERSE COUNTY
AN ORDINANCE CREATING THE
GRAND TRAVERSE HOUSING COMMISSION

WHEREAS, Unsanitary and unsafe housing facilities and housing conditions which are detrimental to the public peace, health, safety, morals and welfare exist in Grand Traverse County; and,

WHEREAS, there is insufficient, safe and sanitary housing facilities for persons who lack the amount of income necessary to enable them, without financial assistance to live in decent, safe and sanitary housing facilities; and,

WHEREAS, there exists no coordinated effort to provide for and monitor the location, planning and construction of additional safe and sanitary housing units in Grand Traverse county; and,

WHEREAS, it is for the public interest that a Housing Commission be created in the County of Grand Traverse;

NOW, THEREFORE, THE COUNTY OF GRAND TRAVERSE ORDAINS:

- Section 1 Pursuant to the Public Act 18 of the Extra Session of 1933, as amended, a Commission is hereby created in and for the County of Grand Traverse, Michigan, to be known as the Grand Traverse Housing Commission.
- Section 2 The Chairman of the Grand Traverse County Board of Commissioners is hereby directed to appoint the members of the said Grand Traverse Housing Commission as soon as possible after this ordinance shall take effect.
- Section 3 The County Clerk is hereby directed to cause this ordinance to be published as soon as possible in the Traverse City Record Eagle, published in the City of Traverse, Michigan and to be posted in three public places in the County of Grand Traverse.
- Section 4 It is the intent of the Grand Traverse County Board of Commissioners to encourage the adoption of contractual agreements between Grand Traverse County and the incorporated municipalities to allow the Grand Traverse Housing Commission to perform the functions required or permitted by Act 18 of the Extra Session of 1933, as amended, in these municipalities as allowed by Section 3.d of the Act.
